Farmers Market Membership Criteria

To be a Farmers Market Member of the WSFMA, markets must:

- 1. Operate a farmers market in Washington State with a minimum average of 5 farmers per market day;
- 2. Adhere to the Roots Guidelines;
- 3. Carry commercial general liability insurance and include WSFMA as an Additional Insured;
- 4. Complete an annual membership application, including 2013 Member Contract; and
- 5. Pay membership dues.

Farm Membership Criteria

Farm membership is open to any farm growing produce, plants or botanicals, or raising animals for direct sale at farmers markets on land they own, lease or rent in the State of Washington. Farm membership is also open to seafood vendors who are legal residents of Washington State and own, lease, or operate the fishing vessel or parcel of land where the seafood is caught or harvested for direct sale at farmers markets.

WSFMA Farm Members agree to:

- 1. Adhere to the Roots Guidelines;
- 2. Complete a membership application; and
- 3. Pay annual membership dues.
